- I. Process for determining who gets Regional equipment
 - 1 set for invitational (If there is no invitational then another region will be given the donated equipment)
 - 2 sets for regionals

Who has had the equipment in the past?

2013 - Region 1, 2 and 3 2012 - 1 & 4 together and 2 Region 3 purchased the equipment for \$6500 from Ross

ISSUE: Region 4 bid for the Regional Meet this year thinking that they would be getting the equipment donated since their region did not receive it last year.

- There are three regions who are hosting the Regional Meet on the same day – AAI can't do three regions at one time.

Region I – April 9th and 10th – does not need equipment Region II – April 9th and 10th – gets equipment Region III – April 4th and 5th – gets equipment Region IV – April 8th and 9th – gets equipment ***PROCESS – appoint a committee to come up with a process (Either Eric or Denise will head the committee and they will decide on three others to help decide the process for which regions each year will receive the AAI equipment)

POSSIBLE IDEAS:

- 1. Each region responsible for donating money to a pot so that all regions have the same opportunity.
- 2. Rotational system (region who is hosting the state meet from the prior year is out not getting the equipment) so whoever is hosting state meet that region would get the equipment.
- 3. THSGCA pays for the region that is not getting the equipment.
