3. TEAM ENTRIES

B. Each team entered in Regional and State gymnastic competition shall be limited to six (6) entries per event, and must have one All Around contestant.

Change to (FAILED)

Each team entered in Districts, Regionals, and State shall be limited to six (6) entries per event. The same competitors entered for the Compulsory competition DO NOT have to be entered in the Optional competition.

The vote was 23-19 in favor of the change. However, it was thought of at the time that a simple majority was not enough to pass. It was thought that 24 was needed to pass since 47 members were present at the beginning of the general assembly meeting.
